

Dear CBHS Scholarship Applicant:

The following scholarships are administered through the Cut Bank Education Foundation and Alumni Association (CBEFAA). Please print off the entire application and check those scholarships for which you would like to be considered on the checklist. In order to be considered for these scholarships, the applicant must attach the following items to the checklist. All additional forms required are also posted on the website and will have to be printed off in order to fill out and submit.

1. An essay by the applicant explaining their future plans and how this award will help realize these plans. (300 – 400 words)
2. A resume of the applicant's school activities, community activities and employment during high school. Please include your name, address (both snail and e-mail), and phone number so we can contact the you if necessary.
3. A copy of the your Cut Bank High School transcript **through 7th semester**. (Applicant is responsible, not the Counseling Center personnel, for including this document in their application packet.)
4. Two scholarship recommendation **forms**, not letters, from **CBHS classroom** teachers who have taught the student. At least one of these forms must be from a teacher of a **core** requirement course. This does not include coaches, aides or School-To-Work employers unless they actually taught the applicant in a classroom setting during high school. Recommendations written by a relative of the applicant will not be considered. **(These forms are on the website and can be printed to provide to the teachers.)**
5. One letter of recommendation from a community or business member. Recommendations written by a relative of the applicant will not be considered.
6. Complete the “Influential Teacher” form and essay (250 words or less). (This form is the last page of the online application posted on the website).
7. Those students applying for the Community Service Scholarships need to check the attached information sheet for the additional items that must be submitted to be considered for this scholarship.

The deadline for this application is 3:45 p.m. February 23, 2012. **No late applications will be accepted.** All applications must be turned into the counseling office at this time. Please review for completeness before turning the application in. **Incomplete applications will not be considered!**

The CBEFAA reserves the right to withdraw a scholarship award if the recipient no longer meets the criteria established for that award, (i.e., receipt of a full scholarship from another source and financial need was one of the criteria used for the CBEFAA awarded scholarship) or not award a scholarship if no applicant meets the established required criteria. Any scholarship not issued will be returned to the appropriate scholarship fund for issuance in future years. The CBEFAA also reserves the right to not award or to modify an award due to unforeseen circumstances.

Additional scholarships may be added to this list and all applicants will be considered for these additional scholarships if they qualify.

Eligibility - CBHS graduating senior in good standing who will enroll in an accredited post-secondary institution. (This scholarship payment will be split in half between the first and second semester of the freshman year.)

_____ **Lillian Larson Memorial Scholarship** **\$500.00 (1)**
Eligibility - CBHS graduating senior in good standing who will enroll in an accredited post-secondary institution. (This scholarship payment will be split in half between the first and second semester of the freshman year.)

_____ **Danny Nanini Memorial Scholarship** **\$300.00 (1)**
Eligibility - CBHS graduating senior who will enroll in a vocational/trade school. Preference given to 4-H members.

_____ **Coleen Tweedy MacMasters Memorial Scholarship** **\$400.00 (1)**
Eligibility - CBHS graduating female senior in good standing who will enroll in an accredited post-secondary institution. Preference given to applicant majoring in business and who will attend University of Montana or another in-state school. (This scholarship payment will be split in half between the first and second semester of the freshman year.)

Eligibility - CBHS graduating senior in good standing who will enroll in an accredited college or university. (This scholarship payment will be split in half between the first and second semester of the freshman year.)

Eligibility - CBHS graduating senior in good standing (at least a 2.00 GPA) who will enroll in an accredited post-secondary institution as a full time student. Preference given based on financial need. Will be issued after student completes first semester of college with a 2.5 GPA or better.

Eligibility - CBHS graduating senior in good standing who will enroll in an accredited post-secondary institution as a full time student. Preference given based on financial need and grades. (This scholarship payment will be split in half between the first and second semester of the freshman year.)

Eligibility - CBHS graduating senior in good standing who will enroll in an accredited post-secondary institution. Applicant must be entering field of education. (This scholarship payment will be split in half between the first and second semester of the freshman year.)
- _____ **Eugene and Susan Boyles Scholarship** **\$500.00 (2)**
Eligibility - CBHS graduating senior in good standing who will enroll in an accredited post-secondary institution as a full time student. Preference given based on financial need. Will be issued after student completes first year of college.
- _____ **Elma and David Epstein Memorial Scholarship** **\$ 1,000.00 (2)**
Eligibility – CBHS graduating senior in good standing who will enroll in an accredited post-secondary institution. Applicant must be entering the field of education. (This scholarship payment will be split in half between the first and second semester of the freshman year.)

Eligibility - CBHS graduating senior in good standing who will enroll in an accredited post-secondary institution (including vo-tech, business, college, university). Applicant must be a deserving recipient. Scholastic achievement, character, and leadership will be considered. . (This scholarship payment will be split in half between the first and second semester of the freshman year.)

_____ **Gene Losing Memorial Scholarship** **\$ 500.00 (1)**
Eligibility – CBHS graduating senior in good standing who will enroll in an accredited post-secondary institution as a fulltime student. Applicant must have participated in basketball or cross country while in high school. (This scholarship payment will be split in half between the first and second semester of the freshman year.)

_____ **The R. Paul Kleinsmith Memorial Community Service Scholarship** **\$1,000.00 (1)**
Eligibility - CBHS graduating senior in good standing who will enroll in an accredited U.S. college or university. Applicants must have completed at least **100 hours** of service to their community from February 24, 2011 thru February 23, 2012. (See attached information sheet for complete details.) (This scholarship payment will be split in half between the first and second semester of the freshman year.)

_____ **The Ray Maier Memorial Community Service Scholarship** **\$1,000.00 (1)**
Eligibility - CBHS graduating senior in good standing who will enroll in an accredited U.S. college or university. Applicants must have completed at least **100 hours** of service to their community from February 24, 2011 thru February 23, 2012. (See attached information sheet for complete details.) (This scholarship payment will be split in half between the first and second semester of the freshman year.)

_____ **Julie Kimmet LaVerdure Memorial Scholarship** **\$300.00 (1)**
Eligibility - CBHS graduating senior in good standing who will enroll in an accredited post-secondary institution. Applicant must be entering field of education. (This scholarship payment will be split in half between the first and second semester of the freshman year.)

_____ **Kathy Ebelt Memorial Scholarship** **\$300.00 (1)**
Eligibility - CBHS graduating senior in good standing who will enroll in an accredited post-secondary institution. Applicant must be entering field of education. (This scholarship payment will be split in half between the first and second semester of the freshman year.)

_____ **Mary Catherine Burke Memorial Scholarship** **up to \$14,000.00 (1)**
Eligibility - CBHS graduating senior in good standing who will enroll at Carroll College as a full time student in the fall of 2011. Student must have already applied and been accepted to attend Carroll College to be considered for this scholarship. The recommended allocation of the scholarship is for \$2,000 to be awarded for the freshman year, \$3,000 for the sophomore year, \$4,000 for the junior year and \$5,000 for the senior year. This allocation may be adjusted on a pro rata basis to comply with the investment spending policy for this scholarship. The financial aid office at Carroll College will be administering this scholarship. This scholarship award will be based on scholastic achievement **and** on demonstrated financial need. **Applicants must have FAFSA on file with the Carroll College Financial Aid Office.**

The awardee will have demonstrated a positive attitude and loyalty to CBHS during the high school years and through these actions shows promise in continuing this successful behavior in a chosen career. Will be issued after student completes first semester of college and is in good standing at the school where they attend.

Dennis & Dixie Roseleip Family Entrepreneurship Scholarship \$500(1)

This annual award is given by the Dennis & Dixie Roseleip Family in appreciation to the Cut Bank Public Schools and the Cut Bank Community. The Cut Bank Schools provided a quality education to the Roseleip children and the Cut Bank community provided an excellent environment to raise a family. Dennis served as the Cut Bank High School Principal (1982-1994) and School Superintendent (1994-2005). Dixie served in the elementary schools as a part-time Counseling and Reading aide (1990s) and enjoyed serving the Cut Bank Community with her R-Glacier Shaved Ice business (1990-1994) and her Lady Bug Express Ice Cream business (1996-2004). CBHS graduates Ryan (Class of '93), Erin (Class of '96), Amber (Class of 2000) and Bobbi (Class of '02) all graduated from universities or specialty schools and are thankful for the preparation they received through the Cut Bank Schools.

Eligibility - CBHS graduating senior in good standing (at least a 3.00 GPA) who will enroll in an accredited post-secondary institution as a full time student. The awardee will have demonstrated a positive attitude, strong leadership skills, an entrepreneurial spirit and loyalty to CBHS during the high school years and through these actions shows promise in continuing this successful behavior as an organizational/community leader and/or entrepreneur/business owner. Will be issued after student completes first semester of college and is in good standing at the school where they attend.

Ken Sammons Memorial Scholarship

Eligibility - CBHS graduating senior in good standing who will enroll in an accredited post-secondary institution. Preference will be given to applicants with a music background. (This scholarship payment will be split in half between the first and second semester of the freshman year.)

Community Service Scholarships

Two students from Cut Bank High School's Class of 2012 may be selected to receive a \$1,000 scholarship for outstanding service to their community. The recipients will receive either \$1,000 given in memory of Mr. Ray Maier, a former teacher at CBHS or \$1,000 given in memory of CBHS alumnus R. Paul Kleinsmith, Class Of '43.

Eligibility – CBHS graduating senior in good standing, who has volunteered at least 100 hours of service between February 24, 2011 and February 23, 2012. No minimum grade point average is required. Applicant must plan to enroll in an accredited U.S. college or university.

What Types of Service Qualify –

The Community Service Scholarships are intended to reward and encourage activities that have a significant impact in meeting the needs of our local community. Types of service include:

- service with community or religious organizations
- service through school or community based service-learning projects; or
- individual efforts to help others and improve the local community.

Fund raising, lobbying, proselytizing, and paid or stipend service do not qualify for these awards. Court ordered community service does not qualify. Those activities for which the student received a grade and/or credit toward high school graduation (i.e., School-To-Work, Live Wire, yearbook, TA, etc.) do not qualify.

What to Submit in Order to be Considered – In addition to the items listed on the first page of this packet, all applicants for this scholarship must submit verification of all service claimed, signed off by an appropriate official of the organization for whom the service was performed. All time claimed by applicant must be accounted for. Please provide phone numbers of officials verifying service. Suggest a form which includes the organization worked for, the type of work performed, the dates and hours work performed, and signature of individual of can verify the service and a phone number. Do not submit individual letters verifying every hour worked. See Ms. Butterworth for further clarification if needed.

This should be submitted as part of the consolidated scholarship application form of the CBEFAA on February 23, 2012 no later than 3:45 p.m. in the Counseling Office at CBHS. **No late applications will be accepted.** Please review for completeness before turning the application in. **Incomplete applications will not be considered.**
